- 3. Hours of the After School program will be from 2:30 until 6:00 p.m. Extended day will be available on some public school holidays from 7:00 a.m. until 6:00 p.m. Advance notice required.

- 4. Transportation to THE OAK FOREST MONTESSORI SCHOOL will be provided by local school buses, OFMS vans or through other personal arrangements.
- 5. Cost of the After School program will be \$260.00 per month. A Supply Fee of \$125.00 will be due upon registration for the 2022-2023 school year, and the second portion of the fee, which is \$100.00, will be due August 1, 2022. These fees are non-refundable and are separate from the summer supply fees.
- 6. Tuition for the After School program will be paid as usual regardless of the student's attendance with respect to illness or other conflicting activities. Fees are due on the 1st of each month. A \$50.00 charge will be assessed on all accounts ten days past due.
- 7. Children will be assessed a late pick-up charge of \$10 for the first 5 minutes and \$1 per minute for any additional time.
