1. This is a binding contract, lasting from August 19, 2019 to May 22, 2020. **All tuition fees will be paid as usual regardless of the child's attendance with respect to illness, vacation, school holidays, etc.**
2. School holidays will coincide with those observed by local public school systems whenever possible.
3. Supply fees will be due in two installments. \$250 will be due when contract is given and the second fee of \$250 will be due August 1, 2019. **These fees are non-refundable.**

4. Tuition for enrollment is as follows:

6. Children will be assessed a late pick-up charge of \$10 for the first 5 minutes and \$1 per minute for any additional time.
7. There is a \$50 service charge for an insufficient check.

Fees shown apply to all children entering the school.

8. I understand this contract is binding and a 30 day notice must be given in the event I'd like to withdraw my child from enrollment. I understand failure to provide 30 day notice will result in the following month's tuition being due.
