- 1. This is a binding contract, lasting from August 2024 to May 2025. All tuition fees will be paid as usual regardless of the child's attendance with respect to illness, vacation, school holidays, etc.
- 2. I understand this contract is binding and a 30 day notice must be given in the event I'd like to withdraw my child from enrollment. I understand failure to provide 30 day notice will result in the following month's tuition being due.

- **3.** School holidays will coincide with those observed by local public school systems whenever possible.
- **4.** Supply fees will be due in two installments. \$250 will be due when contract is given and the second fee of \$250 will be due August 1, 2024. **These fees are non-refundable and are separate from the summer supply fees.**
- **5.** Tuition for enrollment is as follows:
