This binding contract is entered into by the parents/guardians of:

and THE OAK FOREST MONTESSORI SCHOOL. Both parties agree to the following:

1. This is a binding contract, lasting from June 1, 2017 to August 22, 2017. **All tuition fees will be paid as usual regardless of the child's attendance with respect to illness, vacation, school holidays, etc.**
2. All students enrolled in the pre-primary full and extended day programs will nap while at school.
3. Children must provide their own lunch or participate in the lunch delivery program.
4. Fees are due at the beginning of each month upon receipt of statement. **A \$50 charge will be assessed on all accounts ten days past due.**
5. **Children will be assessed a late pick-up charge of \$10 for the first 5 minutes and \$1 per minute for any additional time.**
6. There is a \$50 service charge for an insufficient check.

8. I understand this contract is binding and a 30 day notice must be given in the event I'd like to withdraw my child from enrollment. I understand failure to provide 30 day notice will result in the following month's tuition being due.
