1. This is a binding contract, lasting from June 1, 2020 to August 7, 2020. **All tuition fees will be paid as usual regardless of the child's attendance with respect to illness, vacation, school holidays, etc.**
2. All students enrolled in the pre-primary full and extended day programs will nap while at school.
3. Fees are due at the beginning of each month upon receipt of statement. **A \$50 charge will be assessed on all accounts ten days past due.**
4. **Children will be assessed a late pick-up charge of \$10 for the first 5 minutes and \$1 per minute for any additional time.**
5. There is a \$50 service charge for an insufficient check.
6. I understand this contract is binding and a 30 day notice must be given in the event I'd like to withdraw my child from enrollment. I understand failure to provide 30 day notice will result in the following month's tuition being due.
